- 1.2 The Agent/Rider is unsware of any mental or physical impediment which would prejudice him/her in any activity licensed by Officead Motorsport UK.
- 1.3 The Rider is eligible and compatent (within the meaning of Offroed Motorsport UK rules) to compate in this event organized by Offroed Motorsport UK.
- 1.4 The Rider has a current valid licence or photographic ID as set out above.
- 1.5 The Agent/Rider is aware of Officead Michaeport UK's supervisory function at the event and of it's disciplinary powers.
- Save as expressly agreed to the contrary in the terms of this agreement namely dauses 2, 8, 9 and 11.
- 3 The Agent/filder is aware that but for the provisions of this agreement the fee payable for granting a license would be £1,000.
 It is agreed that:
- On payment of the day liberce fee by the Agent/Rider and in consideration of the warranties set out above and the terms as set out herein. Offroad
 Motorsport UK grants the rider a one meeting competition liberce parmitting the rider to take part in and compete in this event as held under Offroad
 Motorsport UK rules.
- 2. At all times the only duty which Offroad Mintersport UK itself as principal owes or shall owe to the Agent/Rider is
 - 2.1 To ensure the course at this event complies with the minimum standards laid down in the Office of Motorsport rules.
 - 2.2 To exercise reasonable skill and care in selecting the Scrutineer and Clark of the Course.
- 3. The Agent shall operate as a marshal if required to do so by Offroed Motorsport UK
- 4. The Agent/Rider shall walk the entirety of the track on which the rider will compute to ensure that he/she is completely satisfied that the Rider is fit and competent at that time to compete on that circuit without causing injury, loss or damage to himself/herself or any other person or groperty.
- 5. The Agent and the Rider shall abide by Offreed Motorsport UK rules at all times.
- 6. Where, in the opinion of Olirced Motorsport UK, the Agent/Rider breaches any of the Olirced Motorsport UK reles or does not comply with any instruction given by the officials, Olirced Motorsport UK at it's own discretion, may reduce the number of any points awarded to a Rider and/or exclude the Agent/Rider from further participation in any event.
- 7. In the event of any exclusion as set out above, the entry fee paid by the Agent/Rider shall be forfeit.
- 8. The Agent/Rivier accept that the Rider in competing in events will be engaged in hazardous activity which can cause death or personal injury both to the Rider and others in those drawnstances:

The Agent/Alder garees that the Alder freely accepts all risk of death and personal injury occurring in the course of that havedous activity.

- The Agent/Rider accept that Officed Material UK liself as principal does not and will not one the Agent/Rider a duty of care other than that laid down by statute or as provided for by this expressent.
- 9. The Agent/Rider agrees to walve any right of aution which they might have against Officeral Motorsport UK itself as principal and/or having exempt Officeral Motorsport UK as principal from any liability in respect of any loss or demage save where said right of action and/or loss and damage accrues from the actual resilience of Officeral Motorsport UK itself as principal in performance of the duties as set out in clause 2 above.
- 10. For the avoidance of doubt, the Agent/Ridar does not hereby waite any right of action that they may have against independent contractors of Olivoed Motorsport UK or as against Officed Motorsport members.
- 11. The Agent/Rider agrees that for the period of this agreement to indemnify Offroed Motorsport UK in respect of all injury, loss and demage caused to the Rider and/or any property of the rider however caused.
- 12. The Agent/Rider agrees that they are and will be liable for any injury, loss and damage caused by either or both of them, their servants or egents to any other persons or property and agree to indemnify Offroed Motorsport UK in respect of the same.
- 13. The Agent/Rider agrees to waive any right of action which they might have against Offroed Motorsport UK in respect of all and any decision so reached in accordance with Offroed Motorsport UK rules.
- 14. For the purpose of this form the Agent means perent or legal guarden of the ridar.
